### Research on Innovative Development Path of Rural Enterprises Driven by Entrepreneurship: A Case of Rongda Agriculture in Suiping County of China

#### **Abstract**

This paper adopts the case analysis method, combined with the entrepreneurial process and the actual development of industrial innovation of Rongda Agricultural Vegetable Company in Suicping County, Henan Province, in-depth analysis of the practical connotation of rural entrepreneurship, and discusses the driving effect of rural entrepreneurship on the innovation and development of private enterprises and the realization path. The results show that the entrepreneurial spirit includes such elements as "conforming to the general trend, daring to innovate, actively exploring, honest and law-abiding, fulfilling responsibilities", which plays a role in the development of rural enterprises such as strategic innovation, organizational innovation, management innovation, value innovation and market innovation. The cultivation of entrepreneurship should start from the aspects of platform construction, institutional incentive, property right protection and optimization of business environment to promote the construction and development of private enterprises.

#### **Literature Review**



The initial stage of the enterprise: Suicping Rongda Agriculture Co., Ltd. was established in July 2014, located in Danu Administrative Village, Hexing Town, Suicping County, with a registered capital of 14 million yuan. The company aims to establish an efficient green vegetable production and processing base, aiming at nutrition and health, and meeting the demand of consumers in mainland China, Hong Kong and Macao for high-quality green vegetables.

The company has established Rongfeng Professional Cooperative of planting agriculture in Hexing Town of Suiping County and Suiping Yifeng Professional Cooperative of Planting Agriculture. It adopts the mode of "company + base + cooperative + farmer" for development and operation. Village groups are taken as the unit to sign product recycling contracts, promote rural revitalization by industrial revitalization, and realize income increase of farmers, agricultural development and rural prosperity. It will drive the structural adjustment and industrial upgrading of agriculture and rural economy in surrounding areas, and continuously expand the rural collective economy. At the same time, it integrates internal and external resources needed for innovation and development, and constantly ADAPTS to the changes of internal and external environment and market demand through strategic innovation, organizational innovation, management innovation, value innovation and market innovation, which improves the innovation ability of enterprises and promotes the rapid growth of enterprises. Its development stage includes five stages, namely the initial stage of enterprise entrepreneurship, the growth stage of enterprise, the high-speed development stage, the leapfrog development stage and the high-quality development stage, which fully reflects the integration of entrepreneurial spirit in each stage.

#### **Growth stage of enterprises -- actively explore new technologies**

Henan Rongda Agriculture Co., LTD., with an overall planning area of 13,000 mu and a total investment of 310 million yuan, focuses on green vegetable planting and processing and indepth processing, and produces and processes 100,000 tons of fresh vegetables annually. The main varieties are mustard, cabbage, broccoli and so on. On the basis of equality,

Rongda Agriculture Co., Ltd. has advantages in technology, talent, production and sales to provide vegetable farmers with project management, technical consulting, recycling and processing services.

Vegetable seedling supply. There are two smart greenhouses, vegetable factory seedling, supply the surrounding area. Using scale advantage to reduce cost, lay a foundation for high quality vegetable production.

Green vegetable production. The green vegetable planting base is divided into warm shed planting area and open field planting area. The annual production of green vegetables is more than 100,000 tons, with an output value of more than 500 million yuan.

Vegetable dehydrating processing. The annual production of dehydrated fruits and vegetables is 10,000 tons, which can avoid seasonal risks and price fluctuations of vegetables, improve the added value of products, lengthen the green vegetable industry chain, and achieve annual sales revenue of more than 100 million yuan.

Organic fertilizer production. Digest and use agricultural straw and animal waste to produce organic fertilizer with an annual output of 50,000 tons, increase the content of organic matter in cultivated land, solve the problems of soil poisoning and reduced effectiveness of fertilization, improve the quality of vegetable products, improve the surrounding ecological environment, and develop ecological agricultural circular economy.

Technology research and development services. In recent years, through the green vegetable industry, including agricultural materials, packaging, transportation, etc., no matter the company itself, cooperatives, or the collective economy of surrounding farmers and villages, it has achieved relatively significant economic benefits. The yield and utilization rate of land in the park are much higher than those around it. The green vegetables produced in Rongda Agricultural vegetable growing area exceed the national standard of green food, and there is no waste generated in the production process. Products sell well in mainland and Hong Kong and Macao markets.

#### **Phased Achievements**

At present, the vegetable production base has built 130 daylight greenhouses, 700 square meters of cold storage, installed 3 kilometers of rail road, reduce land loss 30 acres , water, electricity, road fully meet the production needs. Underground water pipes have been installed in all vegetable planting bases, and micro-sprinkler irrigation is used for all vegetable water.

#### Period of rapid development -- firmly fulfill social responsibilities

At the same time of its own development, the company takes the initiative to shoulder social responsibilities, actively gives back to the society, and helps poverty alleviation with industry. The Internet + e-commerce platform for agricultural enterprises ensures that Rongda strides forward on the current road of enterprise development. Rongda fully realized the importance of Internet + agriculture at the beginning of its establishment, and was determined to establish its own e-commerce platform to ensure the healthy operation of Rongda's e-commerce platform "Field + workshop: e-commerce platform to logistics system product traceability system, and the marketing model of" stores + individual consumers ".



#### Leapfrog development period -- innovative vegetable planting mode

Rongda Agricultural Company and Rongfeng Agricultural Purchasing and Marketing Cooperative have established a planting base of more than 13,000 mu of high-yield and efficient green vegetables in Danu and other administrative villages in Hexing Town, Suiping County, including 300 mu of greenhouse planting, producing 80,000 tons of green vegetables

annually, with an annual turnover of more than 500 million yuan, driving more than 5,000 farmers to increase their per capita income by 1,500 yuan. The agricultural ecological environment around the base has been improved, the content of organic matter in the cultivated land has been significantly increased, and the land growth capacity has been continuously enhanced. At present, all vegetables produced by the base are sold to Hong Kong and Macao through Shenzhen port. Annual production of 80,000 tons of fresh vegetables, processing of 10,000 tons of dehydrated vegetables project, has the function of avoiding vegetable price risk, optimizing agricultural industrial structure, widening and lengthening agricultural product sales channels, and elongating agricultural product benefit chain. Can create 300 jobs, so that the local farmers income has a new way to increase, the enterprise annual sales revenue of more than 100 million yuan, profit and tax to achieve more than 20 million yuan, most of the dehydrated vegetable products exported to foreign countries.

#### **Cold chain logistics system**

Figure 3: Cold chain logistics of agricultural products of Rongda Agricultural Company



To build a bio-organic plant with an annual production capacity of 50,000 tons, which can digest and use crop straw and animal waste in large quantities, and provide guarantee for the development of ecologically friendly agriculture; It can meet the needs of organic fertilizer for 300000 mu of cultivated land and forest land, fundamentally solve the problems of soil poisoning, hardening and land fertility decline, and provide a solid foundation for the sustainable development of green agriculture. At the same time to provide 400 jobs, the enterprise achieved sales revenue of 110 million yuan. In order to adapt to the integrated development of rural industries, promote the adjustment of rural planting structure, share the dividends of industrial integration, promote rural revitalization and increase farmers' income, the company has built a new dehydrated vegetable processing plant with an annual production of 10,000 tons of dehydrated vegetables. The products are mainly vegetables

In 2019, Rongda Agricultural Company and Hong Kong Dpai Group jointly established Dpai Agricultural Technology Co., Ltd. to expand overseas markets, improve international trade share, build local brands, and enhance the popularity of Suiping County's agricultural products. Rongda Agricultural Company signed vegetable planting contracts with 24 village collectives and 40 poor households in Hexing Town, which increased the income of poor households and rural collectives, and also brought more employment opportunities for local people, including poor households. With the development of economy and the improvement of living standards, the company plans to create a garden complex of fruit and vegetable picking, science education, personal interaction, farming experience and other functions in one, so as to meet people's close to nature, relieve work pressure, enhance family harmony, fashion and healthy lifestyle, and meet the diversified needs of urban and rural people.

# Analysis on the innovative development path of Private enterprises driven by entrepreneurship

#### Conform to the trend of The Times and assume the responsibilities of the country

The products are mainly vegetables suitable for local cultivation, including carrot, spinach, lettuce, mustard orchid, cabbage heart, bitter melon, okra, purple sweet potato, etc. The product structure will be adjusted according to market demand in the future. It can process 80,000 tons of fresh vegetables and produce 10,000 tons of dehydrated vegetables annually. Annual sales of fresh sweet potato 500,000 tons, dried high-quality varieties of sweet potato (sweet potato chips, sweet potato grains, sweet potato strips) 100,000 tons, processing sweet potato powder 300,000 tons. After completion of the project, it can effectively promote the development of local vegetable, melon and fruit planting industry, achieve agricultural value-added, farmers' income increase, enterprise development, and multi-party win-win. Therefore, establishing a good relationship with the public is the key point for the future development of enterprises.

# Entrepreneurship cultivation and external stimulation of countermeasures and suggestions Give full play to entrepreneurs' innovation and entrepreneurial wisdom

Entrepreneurship is the intangible assets of enterprises. The key of intangible assets management is to improve the efficiency of asset conversion and transform intangible assets into actual economic benefits. Entrepreneurs themselves have a strong sense of responsibility and mission (Atherton & Newman, 2017). The key to developing high-quality enterprises is to give full play to the wisdom and talent of entrepreneurs in innovation and entrepreneurship, so that entrepreneurs can become the first person responsible for the development of market economy. The government and other relevant departments should do a good job in supporting the platform, so that entrepreneurs have places to display their talents, space to grow their skills, time to plan for development, resources to make full use of, and opportunities to grow rapidly. Entrepreneurs should be encouraged to start their own businesses and innovate consciously, so as to form a positive and virtuous cycle of development mechanism. In the real economy, entrepreneurship is the core driving force; When it comes to food safety, for example, entrepreneurship is the first barrier against risks. In terms of product innovation, it is necessary to guide enterprises to adapt to the complex competitive environment through entrepreneurship and grasp the changes in social demands in the first time, so as to create new value and improve the overall welfare level of the society.

#### Stimulate entrepreneurs' awareness of innovation and entrepreneurship

Existing entrepreneur resources should be fully utilized and potential entrepreneur resources should be deeply explored. In the aspect of entrepreneur innovation and entrepreneurship,

not only the subjective initiative of entrepreneurs should be relied on, but also the effective stimulation should be carried out (Holmberg et al., 2017). First, we should fully understand the actual needs of entrepreneurs for innovation and entrepreneurship, guide them to pay attention to major fields and key links related to social and economic development, and stimulate entrepreneurs to start their own businesses. The high-level needs implement; Second, it is necessary to build up entrepreneurs' confidence in innovation and entrepreneurship, stabilize their entrepreneurial psychological expectations, take multiple measures to promote entrepreneurial activities, and promote the continuous achievement of innovative undertakings. Third, policies should provide incentives for entrepreneurs to innovate and start businesses, and provide them with material rewards, spiritual incentives, action support and effective management. Fourth, regular vocational training should be carried out for entrepreneurs to enhance their ability of market insight, strategic decision-making, enterprise management and risk control, so as to improve their return rate of entrepreneurship and success rate of technological innovation. We will strengthen the internal driving force for entrepreneurship.

#### Strengthen IPR protection for entrepreneurs' innovations

The protection of entrepreneur innovation intellectual property rights is the system guarantee to encourage entrepreneur innovation. It is necessary to make full use of entrepreneur innovation to improve social welfare, but also to pay full attention to the protection of entrepreneur innovation rights and interests, to ensure that entrepreneur innovation has benefits, so as to realize the fairness and justice of innovation (Gerrans & Hutchinson, 2020). The formulation of intellectual property policy should reflect the rationality of law and reason local measures, industrial measures, and enterprise measures should not only take into account the innovation resource gap between regions, but also combine specific real industry and social needs to protect the enthusiasm of enterprises to start businesses. Fully develop local excellent enterprises and enterprises support small, medium and micro enterprises, form industrial agglomeration effect, and promote the construction of regional industrial brand. In the process of industrial development, the departments making and executing industrial policies should take the initiative to carry out research on policy demands, coordinate the resource demands of enterprise innovation factors, and match the demands of enterprise innovation policies. In the process of entrepreneurship, entrepreneurs and government departments should make joint efforts to create a cultural atmosphere for entrepreneurial innovation, establish the basic rules of industrial competition, and form an orderly and complementary collaborative development mechanism among enterprises. We should combine the development of enterprises with the macro-planning of social and economic development, and carry out scientific and technological innovation and entrepreneurial activities in an organized way.

#### Create a favorable external business environment for enterprises

Fostering entrepreneurship requires not only internal impetus, but also a sound external business environment. In October 2019, The State Council officially promulgated the Regulations on Optimizing the Business Environment, which fully demonstrates the importance of the business environment to entrepreneurs' innovation and entrepreneurship. To create and improve the business environment, first, we need to promote data sharing and openness. The government should stabilize enterprises' expectations and guide future investment by opening up data. Second, in the process of macro-market economic

management, economic efficiency and fair competition of enterprises should be taken into account, giving full play to the creativity of the market and the ability to optimize the allocation of resources; Third, deepen the distribution of the right to use, disposal and usufruct of scientific and technological innovation achievements, and firmly safeguard the usufruct of scientific and technological innovation achievements of enterprises; Fourth, promote the facilitation of trade of private enterprises, reduce the number of unnecessary administrative approval and inspection, and implement various preferential policies for scientific and technological innovation of private enterprises (Fernandes & Machado, 2022); Fifth, we should publicly recognize the achievements of private entrepreneurs' innovation, carry forward the innovative spirit of entrepreneurs, and promote the sustainable growth and innovation of enterprises.

#### **Summary**

Private enterprises are an important part of the market economy, entrepreneurs are the organizational core of private enterprises, and entrepreneurship is the key driving force of pooling strength, resources, innovation and development. At present, the number of private entrepreneurs is increasing, becoming an important force for social economic growth and scientific and technological innovation. At this stage, the main task is to cultivate entrepreneurs, develop entrepreneurs and carry forward the entrepreneurial spirit. The case study proves that entrepreneurship plays a strategic role in entrepreneurial activities and innovative development of enterprises, and can effectively promote private enterprises to make correct decisions in the face of policy, environment, society and resource changes. At the same time, private entrepreneurs are in the stage of development. In addition to giving full play to their entrepreneurial ability, they also need to constantly inject energy into the formation of entrepreneurial spirit and promote their own growth. The social responsibility and mission of entrepreneurs should be clearly defined, therefore that they can fully and deeply integrate with national strategies in business operation and management. In terms of external driving of entrepreneurship, we should start from the perspectives of building an entrepreneur innovation platform, protecting enterprise intellectual property rights and optimizing the business environment, build a platform for entrepreneurs to do business, create an atmosphere for entrepreneurs to innovate and start businesses, protect the legitimate rights and interests of private entrepreneurs to innovate and start businesses, create a sustainable and stable business policy environment, and promote the high-quality development of private enterprises. In the future, when there are mature entrepreneur groups, they should be committed to creating a fair competition environment to promote the stable development of the industry. Enterprises and the government should make joint efforts to fulfill their social responsibilities, and form a development situation of common development, joint investment, sharing of results, sharing of responsibilities and controlling risks on the whole, so that each subject can be a builder and each subject can be a beneficiary. Let entrepreneurship become the core brand assets of private enterprises.
